Section 1: That the monthly rates and charges for trash pick-up service supplied by the City of Narka and consumed or used within or outside the city limits will be as follows:

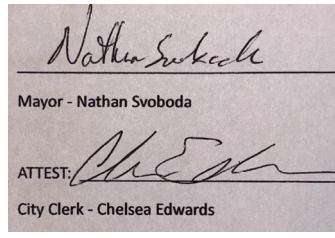
Section 1: A monthly charge of \$17.00 per month for trash pick-up service.
